Directions (from Chicago): 1-94 south to I-57. I-57 south to Kankakee. Exit at Court St./IL-17 West (right). IL-17 west approximately 13 miles to Herscher Road. South (left) on Herscher Road four miles to registration area at the Village Park.

Course: 50K double loop (no turn around) on well-paved, lightly traveled roads. Open to traffic.

Entry Fee: \$20.00 — \$40.00 per team (includes ABR and IBR surcharges). No late fee will be charged for entries received by mail prior to race day. \$3.00 late fee per person (\$6.00 per team) day of race. One-day ABR license may be purchased on race day for \$4.00. Juniors race free (no entry fee).

Pre-Registration: To pre-register and receive a confirmed start time, you must submit both team members' 2005 ABR release form(s), check(s) and a stamped, self-addressed envelope or e-mail address postmarked on or before July 5, 2005. If you are sending separate ABR release forms, please indicate teammate's name and category on the form. Missing items and those completed on race day will be considered a late entry. Make check(s) payable to Midwest Masters Cycling Team. Send release form(s) and check(s) to:
