**COURSE:** 30 Kilometer out and back course. Start on Cherry Valley Road, turn right onto River Road South for 4mi. then turn right onto Fairdale Rd./East Line Rd for 5.5 miles. Turn around just before Hwy 72 and return on same course to the finish just before Cherry Valley Road.

**Starting order: 9:00 am Start.** One-minute intervals. Starts based on order of registration.

### AWARDS:

**Medals** awarded five (5) deep in all classes except Juniors (3 places).

Fastest rider for each of the above categories (\$20) \*must have minimum of 3 riders in category

**Profile for Speed:** Rider entry raffle for merchandise (Profile Aero Bars).

**Overall Fastest Male and Female Riders:** Fastest times for the day cash awards (1st \$30, 2nd \$20, 3rd \$10).

**MATTS:** Points awarded towards 2005 MATTS point series and \$5000 in overall Season cash prizes.

**REGISTRATION:** Will open at 8:00am at Baumann Park.

**Entry Fee:** Pre-registration: \$17 (RACE DAY registration \$20). Racers who choose to compete in more than one category or for a faster time may race a second time for an additional \$10.

**Juniors racing in Junior category - race free.**
