**COURSE:** 30 Kilometer out and back course. Start on Cherry Valley Road, turn right onto River Road South for 4mi. then turn right onto Fairdale Rd./East Line Rd for 5.5 miles. Turn around just before Hwy 72 and return on same course to the finish just before Cherry Valley Road. **Starting order:** 9:00 **am Start**. One-minute intervals. Starts based on order of registration.

**MATTS:** Points awarded towards 2006 MATTS point series and \$5000 in overall Season cash prizes.

WIIL ROTY Points awarded towards Wisconsin-Illinois 2006 Rider of the Year competition.

**REGISTRATION:** Will open at 8:00am at Baumann Park.

**Entry Fee:** Pre-registration: \$17 (RACE DAY registration \$20). **Juniors** racing in Junior categories race for \$5 /day. Racers who choose to compete in more than one category or for a faster time may for \$10. \*ABR membership required, Annual license \$25, Junior (<19) Annual \$10, One day \$4
