FROM THE NORTH (ROCKFORD)

Go south on I-39 Drive 21.0 miles to junction with I-88 (exit 97) Go east onI-88. Drive 15.6 miles to exit #65. Go north on Peace Rd. Drive 1.5 miles. Turn right on East Lincoln Highway (Illinois Route 38). Drive 6.5 miles. Turn left on East County Line Road Drive 0.6 miles Turn right on Main Street.

FROM THE WESTERN SUBURBS (WHEATON)

Go west on IL-38 14.2 miles from the intersection of Randall and IL-38 in St. Charles, to East County Line Rd. Turn right on East County Line Road. Drive 0.6 Turn right on Main Street.

FROM CHICAGO
