**Course:** 50K double loop (all right turns & no turn around).  
**NOTE: 25K single loop for all Juniors, Masters Women 70+ & Men 70+.**  
Well paved, lightly-traveled roads. Open to traffic.

**Directions (from Chicago):** 1-94 south to I-57. I-57 south to Kankakee. Exit at Court St./IL-17 West (right). IL-17 west approximately 13 miles to Herscher Road. South (left) on Herscher Rd. 4 miles to registration area at the Village Park.

**Entry Fee:** \$20.00 — \$40.00 per team (includes ABR and WILL surcharges). No late fee will be charged for entries received by mail by Friday, July 8, 2011. \$5.00 late fee per person (\$10.00 per team) day of race. One-day ABR license may be purchased on race day for \$5.00. Juniors race free (no entry fee) for 25K course.

**Pre-Registration:** To pre-register and receive a confirmed start time, you must submit **both** team members' **2011** ABR release forms, checks and an e-mail address received **on or before July 8, 2010.** If you are sending separate ABR release forms, please indicate **teammate's name and category** on each form. Missing items and those completed on race day **will be considered a late entry.** Make checks payable to Midwest Masters Cycling Team. Send release forms and checks to:

**Important 2nd Ride Info:** Those racers wanting to do a 2nd ride with either the same or different partners may do so but must follow these special instructions:

1. Must preregister **both** teams for **both** rides including **waivers & fees.** (The 2nd ride entry fee is \$10 and is only available for those doing their 2nd ride of the day.)
2. All waivers & fees for both partners & both rides must be received by Friday **July 8, 2011.**

All teams with at least one partner doing a 2nd ride will be assigned 1st ride start times counting back from 9:00 AM at one minute intervals. The earliest start will depend upon the number of 2nd ride entries. **A 2ND RIDE WILL NOT BE ALLOWED IF ABOVE REQUIREMENTS ARE NOT MET.**  
**THERE WILL BE NO 3RD RIDES.**

We want to accommodate those who are contending in more than one category or age group, but we also want to have a timely awards presentation. We hope this arrangement will allow both.

Same day registration opens at 7:30 a.m. and closes at 9:30 a.m. Team starting order based on order of entry — first to register is first to start. First single ride team off at 9:01 a.m. Others follow at one minute intervals.
