Riders are only allowed to warm up on the north side of Rt. 20 away from the start/finish area. Start will be on Garden Prairie Rd. just south of Rt. 20. Course may be modified if road conditions warrant. Route 20 is a busy highway be careful crossing road. **REGISTRATION:**
