Course: 20 Kilometer out and back course. Start line is on River Rd. south of railroad tracks at Deer Run. From start line ride South for 3mi. then turn right onto Fairdale Rd./East Line Rd for 5.5 miles. Turn around just before Hwy 72 and return on same course to the finish near Start at Deer Run. This avoids racing over railroad tracks and being stopped by trains.

Starting order: 9:00 am Start. One-minute intervals. Starts based on order of register

REGISTRATION: Will open at 8:00am at Baumann Park, 298 S Walnut St, Cherry Valley, IL.

Entry Fee: Pre-registration: **\$20 to 08/30/13** (RACE DAY registration **\$25**).

Juniors racing in Junior categories race for **\$5 /day**. Racers who choose to compete in more than one category or for a faster time may for \$10.
