<u>COURSE</u>: 20 Kilometer out and back course. Start line is on River Rd. south of railroad tracks at Deer Run. From start line ride South for 3mi. then turn right onto Fairdale Rd./East Line Rd for 5.5 miles. Turn around just before Hwy 72 and return on same course to the finish near Start at Deer Run. This avoids racing over railroad tracks and being stopped by trains.
